40 YEAR LIMITED WARRANTY

Can-American Corruagating Co. Ltd's policy of quality and durability in the manufacturing of its painted roofing and siding products, CA 2000, Pro Fit® and R-Panel® are represented by this Limited Warranty. This Limited Warranty is valid for a period of forty (40) years from the date of shipment as per provisions below.

WARRANTY COVERAGE

- During the terms of this Warranty, the painted panel will not perforate or fail structurally due to deterioration from red
 rust.
- 2. The paint will not:
 - A) Crack, check or peel (lose adhesion) for forty (40) years.
 - B) Chalk in excess of a numerical rating of 8 when measured with the standard procedure specified in ASTM D4214-98, Method D659 on sidewalls for a period of thirty (30) years from installation or thirty and one-half (30 ½) years from application. CA Red is for a period of ten (10) years from installation or 10 and one-half (10 ½) years from application.
 - C) Chalk in excess of a numerical rating of 6 when measured with the standard procedure specified in ASTM D4214-98, Method D659 on roofs for a period of thirty (30) years from installation or thirty and one-half (30 ½) years from application. CA Red is for a period of ten (10) years from installation or 10 and one-half (10 ½) years from application.
 - D) Fade or change colour by more than 5 units Hunter ΔE units for sidewall panels in accordance with standard procedure of ASTM D2244-02, for a period of thirty (30) years from installation or thirty and one-half (30 ½) years from application. CA Red is for a period of ten (10) years from installation or 10 and one-half (10 ½) years from application. The exposed paint surface, which has been cleaned of any surfaces soils and chalk, will be used to measure color change, coupled with the related values measured on the original or unexposed painted surface. Furthermore, it is acknowledged that fading or color change may not be consistent is sun and element exposure is not equally distributed.
 - E) Fade or change colour by more than 8 units Hunter ΔE units of colour for roof panels in accordance with standard procedure of ASTM D2244-02, for a period of thirty (30) years from installation or thirty and onehalf (30 ½) years from application. CA Red is for a period of ten (10) years from installation or 10 and onehalf (10 ½) years from application The exposed paint surface, which has been cleaned of any surfaces soils and chalk, will be used to measure color change, coupled with the related values measured on the original or unexposed painted surface. Furthermore, it is acknowledged that fading or color change may not be consistent if sun and element exposure is not equally distributed.

LIMITATIONS OF WARRANTY

- This Warranty is extended to the original buyer only and is not transferable or assignable.
- 2. Abnormal atmospheric conditions to which this Warranty does not apply include, but are not limited to hail, exposure to corrosive or harmful chemicals (whether solids, liquids, or gases), airborne contaminants, animal wastes, exposure to salt water spray, decaying materials, wet absorptive material, and internal contamination created by improper ventilation or improper housekeeping. The Warranty does not cover damage caused by acts of God, falling objects, external forces, explosions, fire, riots, civil commotion, an act of war, excessive radiations or other such similar or dissimilar occurrences beyond our control.
- This Warranty does not cover damages to the product's finish caused by handling, shipping, transit, processing, storage or installation.
- This Warranty does not cover failures resulting from edge corrosion.

BUYER'S OBLIGATION

- The Buyer shall inspect material received from Can-American Corrugating Co. Ltd. prior to installation so as to mitigate
 expenses involved in repairing, replacing defective sheets. The Buyer accepts responsibility upon receipt of the material
 in the conditions described in paragraph 3 of Limitations of Warranty.
- Any claim on account of defect in the products or for any other cause whatsoever shall be deemed waived by Buyer
 unless written notice thereof is given to Seller within thirty (30) days after discovery of the defect and within the
 applicable warranty period. Buyer must submit proof of purchase in the event of such a claim. Seller shall be given
 reasonable opportunity to investigate all claims.

EXCLUSIVE REMEDY

If any of our products fail to perform as warranted, the company will, at its option, repaint or replace the defective panels or refund the buyer the price paid for the material. The Company's total liability is expressly limited to the purchase price of the defective material. Except as provided herein the company shall not be liable for any losses, damage or expense, whether direct, incidental or consequential, caused by or resulting from the use of defective or non-conforming products. THE EXPRESS WARRANTIES AND REMEDIES STATED HEREIN ARE THE EXCLUSIVE WARRANTIES AND REMEDIES APPLICABLE TO THE PRODUCTS. ALL IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE EXPRESSLY EXCLUDED.
